## **Statement of Consultation and Community Involvement**

## Introduction

This Statement of Consultation and Community Involvement sets out in broad detail how the North Devon Coast AONB Partnership will consult on the review of the existing 2014-2019 North Devon Coast AONB Management Plan.

The AONB Partnership has agreed that a 'light touch' review should be undertaken and not a wholesale change to the Plan that is working well and delivering positive outcomes across the AONB. There are minor amendments to existing objectives or policies to make the document more concise, more comprehensible and to better reflect current context and terminology. Most changes are in restructuring and updating the evidence or context and forces for change to inform priority actions for delivery of the objectives and policies.

## **The AONB Management Plan**

The revised AONB Management Plan will comprise two parts:

Part 1 is the main strategy document, setting out the vision, context, objectives, policies, priority actions and indicators.

Part 2 will contain the supporting documents: State of the AONB report 2014-2018, environmental assessment screening, evidence documentation and statements of consultation and approvals.

(N.B. Details on the delivery of the Plan will be included in the AONB's Annual Business Plan produced early each year)

We will consult internally and externally on the draft main strategy document (Part 1), confirming the context is relevant and up to date and the evidence and forces for change are appropriate.

This Statement of Consultation and Community Involvement sets out the minimum we will apply in undertaking consultation and engagement with the public and the table below shows how we intend to consult at each stage of the review. We may add to the process below and any updates will be posted on the AONB website.
